## The Wilde Bunch Board Meeting January 12,2022

**CTC:** <u>Matt Thomson</u>: Those who have selected for rollover registrations CTC 2020 which were canceled by COVID will be applied to the next CTC = 2022. Need more outreach and anyone who is visiting another club can bring flyers or ask the club they are visiting if they can make an announcement. Cost is \$75 for early registration and increases to \$90 on March 15th, 2022.

**ASDC:** <u>Adam</u>: Members should be encouraged to consider running for the board of ASDC. Our club should take an active part in ASDC. There are 3 openings on the board. Put out feelers for candidates and those that have run before will be asked to try again.

WILDE BUNCH REOPENING GUIDELINES: The Wilde Bunch went Dark via an emergency email vote on January 10, 2022 due to rising number of COVID cases. It was unanimous by the Board Members to go Dark for 01/10/2022 and address the issue at the 1/12/22 board Meeting. Discussion on what organization to rely on for "latest" COVID suggestion. Adequate time for any changes to require members to comply. Might take up to 2 weeks to schedule boosters because the city is in short supply of healthcare workers to administer the vaccine/booster. KN95 MASKS are not easy to find and are running \$2 each. Cloth and surgical masks no longer meet the requirement of omicron.

**Motion** by Jack Denvir require "Up-to-date" proof of vacations and provide adequate proof to the Board.

Second by Darlene Blackwell. Motion Accepted. (unanimous)

**Motion** by Jack Denvir that KN95 or equivalent masks will be worn at all dances. The club will provide KN95 masks if member is unable to do so.

Second by Nancy Jane Heilman. Motion Accepted. (unanimous)

## Discussion continued on reopening:

Snacks - only individually wrapped snacks. All members are complying.

We closed on 1/10/22 and how long to stay dark? Where should we get information is of concern. Previously it was when the schools closed. That is no longer a viable resource. Should we say dark for the next 3-4 weeks is the question. If conditions improve the board may reconsider the decision to go Dark.

**Motion** by Jack Denvir that The Wilde Bunch will stay Dark at present and return to dancing on 2/14/2022.

Second by Susan Moore Motion Accepted. (unanimous)

**Anniversary Dance:** Set for March 26, 2022 3pm-5:30pm. It was decided to keep the Anniversary Dance "on the Books" based on changing COVID reports.

Secretary Darlene Blackwell will receive any corrections to the draft minutes via email. Adam will coordinate a time and place to give Darlene the keys to the Club PO Box. Adam and Susan will discuss Secretary of State log-in and club affairs via Zoom meeting to be scheduled.
