# Tabled by-law Change from the 2021 General Meeting

"Shall the general membership amend **Art III Sec C** and change term length from 24 month terms to 12 month terms. Change wording from 3 to 6 consecutive terms (still a limit of 6 years).

Current bylaws read as: Section C II "Members of the Executive Board are elected to specific Executive Board positions for twenty-four (24) month terms, which begin January 1st ands end on December 31st of the following year. Section C III B No person may serve more than six consecutive terms in same Executive Board position. For purposes of this provision, appointment to fulfill a vacancy on the Executive Board does not count as a. "Term".
