- Cline will investigate cost to non-Wilde Bunch members for the Jerry Junck dance

IV. Outreach Director: Kroll

 Shirts will be printed by Kroll so we will only need to pay for the shirts themselves, no printing: delivered after A & C weekend

V. Chase the Chili 2010: Spata

- Portland A & C 2010 weekend has been changed to the week before Chase the Chili 2010 so we will have a higher attendance, at least from the Wilde Bunch.
- Everything else is done, except decorating, registration and potluck organization.

VI. A & C Weekend: Kroll

• The numbers are lower than we expected (about 20%).

- All Join Hands has been asked to sponsor the Trail-In Dance. Gordon Macaw has requested our budget, how it will help All Join Hands and who has been invited so they can consider our request.
- Expenses for travel have been overestimated for the callers.
- To get the attendance up, it was suggested that we get a copy of attendance at previous A & C events and compare that list to who has registered for A & C 2009. If they haven't registered, Kroll and/or the Wilde Bunch could market directly to the unregistered parties.
- Kroll is currently working on the caller schedule for the event.
- Ad hoc committee has been established to help plan the event: Kroll, deJong, Cline and Amspoker have volunteered for the committee.

VII. Exhale Performance on November 6, 2009

 Spata has told Exhale that we will do the performance but she hasn't heard any new information at this time.

IX. Class Structure Issues: Spata

- New class starts September 14, 2009
- Cline, previous Class Director, has passed the Class Director materials to Spata to give to the new Class Director when they are selected.
- New class structure starts tomorrow: 7-8 PM will be Basic and 8-9 PM will be Plus. 6:30-7 will still be full-Plus.
- There is some interest in offering a C-1 class so the club will investigate
 offering this on Tuesday nights with a single fee required to take the class.

X. 2010 Board of Directors and Callers: Spata

- There is some concern about members running for the Board next year.
 We need to identify a strong Nominations Committee so Board members may be identified.
- There was discussion about dissolving the Wilde Bunch due to apathy from the members and either letting the club either go to a caller-run club or simply stop dancing completely.
- deJong has been identified as the person responsible for developing a caller evaluation/performance review to be used annually for reasons of caller improvement and feedback.
- Committee has been identified to give comments and feedback about callers as a way of improving caller performance and club strength.
- Board members are to individually develop a couple of bullet points about what their position entails; a letter will be sent to members about what Board members do so they can get interested in running for the Board in 2010.
